THE continuing pursuit of Northern Ireland veterans is grossly iniquitous and unfair.

I have first-hand experience of this. In Belfast in 1973 my driver, Private Raymond "Tapper" Hall, was kneeling by my Land Rover, acting as a sentry, and was shot in the back and killed.

Has anyone ever investigated his murder? No. He was a soldier and soldiers get shot on duty. But on my last day in the Army as Chief of the General Staff my last appointment was with two investigators from the Police Service of Northern Ireland.

They came to talk to me about an Irish gentleman who had been shot dead on that same day and in that same area. He had

almost certainly been shooting at us. Another of my soldiers had been shot and wounded that

day, too. These investigators interested in following up the death of my driver. No one has ever taken a blind bit of interest in my driver

All they were interested in was

suspected terrorist. This shows the barrenness and complete lack of integrity of the process.

It is largely inspired by Sinn Fein trying to rewrite history to their own advantage as part of their tactics to achieve their strategic aim of getting Northern Ireland to join the

Republic of Ireland as one country. It just will not wear.
Currently six veterans are being tried or facing trial over deaths in the Troubles, including Dennis Hutchings.
If I were him, I would be

hugely encouraged that the state of the evidence presented in the trial of Soldiers A and C was unacceptable.

It shows the weakness of this whole legacy business for the judicial system. How can you credibly and with integrity pick up cases that are 49 years It is not a level playing field. The Army kept detailed records; the terrorists kept none. No wonder the

investigators come running to the Army for information.

But if it turns out that Soldier A and C's trial was based in part on answers, they gave to questions to the Historical Enquiry Team in a process to give closure to the family of Joe McCann, that would be outrageous

If that is the case, why would any sensible

veteran give any information to an inquiry team again?

I have seen the figure that 200 deaths allegedly caused by members of the Armed Forces during the Troubles are

being looked at. It means many more veterans face these

being charged and tried over events decades ago.

My advice to any veteran is simple: Do not say anything. Do not cooperate. You are in serious danger of being stitched up.

I was in court in Belfast.

I have sympathy for the McCann family too. War is messy. People do things you don't expect. Actors pursue their beliefs to the point of no return. But they are victims in this too. The way our politics has become stuffed full of imposters with a belief in almost nothing. Who could not for one moment consider the human impact of their inaction. Imagine if Soldier A or Soldier

Military leaders: Stop prosecuting British soldiers

SENIOR military commanders yesterday told Boris Johnson to stop the persecution of British veterans and serving troops.

A fetter signed by three retired generals, an admiral and a former commander of British troops in Afghanistan, raised particular objection to the witch-hunt against Northern Ireland veterans. Ireland veterans

But the Overseas Operations Bill, which this week imposed a five year time limit for prosecutions of soldiers unless there is compelling new evidence, does not cover Northern Ireland.

for actions legitimately taken in the line of duty "In particular, we object to prosecutions over events in Northern Ireland."

The letter highlights the plight of "Soldier F" over Bloody Sunday in 1972 in which British soldiers shot and killed 14 civilians during a protest march in Londonderry

to the local brigade commander, commanding officer and company commander.
"Yet the only person being held to account is a solitary lance corporal."

The senior officers accuse successive governments of failing to honour the Military Covenant, which pledges support for military personnel in return for the risks they take. It states: "Natural justice alone demands that those placed in harm's way by their nation and at the orders of a chain of command are entitled to the reciprocal support and protection of that nation."

Hundreds of thousands failed by lack of understanding of energy impairments – new report

Based on large scale quantitative and qualitative research, a new ground-breaking report "disrupts stereotypes and exposes the systemic failings that harm the lives of hundreds of thousands of people in the UK".

The report is based on emancipatory disability research by the **Chronic Illness Inclusion Project**, part of the **DRILL programme**, supported by the Leeds University Business School, CERIC, LSSI, ESRC and published by the Centre for Welfare Reform.

It presents the findings and recommendations from a study into social inclusion, employment and social security for Disabled people with **energy limiting chronic illness** (ELCI).

People with ELCI have a range of medical diagnoses, and symptoms may vary and fluctuate, but the overall impact on their lives is of energy impairment. They have to carefully ration their energy every day in order to avoid aggravating symptoms.

Examples of ELCI include: ME/CFS (myalgic encephalomyelitis/chronic fatigue syndrome), fibromyalgia, lupus, chronic pain, Ehlers Danlos syndrome, as well as conditions causing: respiratory failure, kidney failure, inflammatory bowel conditions, sickle cell disease, autoimmune conditions, neurological conditions, endocrinological conditions, and rheumatological conditions.

The new report is timely in addressing the circumstances of those 1.1m people experiencing Long Covid.

According to the new research, people with ELCI experience high levels of social isolation, stigma, and lack of representation.

In its Executive Summary, the report says: "One in three disabled people of working age in the UK experiences impairment of stamina, breathing or fatigue. This is the current closest match to the concept of ELCI. Despite the size of this group, employment and social security policies and systems have not considered or been designed for the particular needs of this group of people."

It adds that: "Until now, policy makers have identified this group through various categories of medical diagnosis, or through the catchall term 'long-term health conditions'. **Read more here.**



Our history

The Veterans Association was set up towards the end of 1947.

It followed the birth of the Sainsbury's Staff Association, which allowed all pensioners to be admitted free of charge. During the latter part of 1947 it was thought that many pensioners would appreciate the opportunity to renew contact with old friends through the SSA and that they might be pleased to assist at local SSA functions. Eight ex-colleagues expressed an interest in becoming involved and the Veterans Association was born.

Why do we have a Veterans Association and veterans benefits?

Veteran colleagues have given an invaluable service to Sainsbury's over the years. The company values their contribution to its success and recognises this by enabling a range of benefits to be offered in retirement. Some of these will happen automatically, others are optional. Sainsbury's offers a wider variety of benefits compared with many other companies.

What is a Veteran?

 A Sainsbury's 'Veteran' is an ex-colleague who has left the Company due to retirement, ill-health, or redundancy and who meets a qualifying eligibility criteria, at the actual time of leaving the Company.

- The eligibility criteria has changed several times since 1997.
- The eligibility, since April 2006, is 25 years continuous service and leaving due to retirement, ill-health, or redundancy.
- If a colleague qualifies to become a Company Veteran, membership is automatic.
- If a current Company Veteran dies and leaves a surviving spouse, their spouse becomes the Company Veteran.
- The Veteran benefits only apply to actual Company Veterans.
- We do, however, invite ex-colleagues who have retired but may not have qualified to become a Company Veteran to join a local association.

Veterans UK start an exercise to correct some Restored Widows' Pensions

Veterans UK are conducting an administrative exercise to revisit commencing dates for restored widows' pensions under the War Pension Scheme, to identify and pay additional amounts where necessary, after a Court of Appeal ruling.

We are now beginning to contact and pay widows and estates where we know pensions have been restored from an incorrect commencing date. Where we have any contact details recorded in cases where widows have died, we are writing to people to make them aware of how to apply if they think that there may be money owed because a pension was restored from the wrong date.

However, we do not hold full details of the estate for all those customers who are now deceased, so you should claim if you believe you have an entitlement. More detailed information about the exercise, guidance on eligibility and how to apply can be found on <u>Additional period of Restored War Widows/War</u> Widowers Pension.

It is likely to take a considerable amount of time to work through contacting people and then deal with applications, we will provide updates on progress on GOV.UK.
